## RESOLUTION OF THE TRUST AUTHORIZING THE PURCHASE OF H2LOANS PROGRAM COMPONENTS

WHEREAS, the New Jersey Environmental Infrastructure Trust (Trust) is authorized to make and enter all contracts necessary or incidental to the performance of its duties pursuant to N.J.S.A. 58:11B-5(d); and

WHEREAS, in Resolution No. 13-72, the Trust authorized execution of a Memorandum of Understanding with the New Jersey Department of Environmental Protection (DEP) wherein the parties agreed to various terms pertaining to the development of a web based application and loan administration system for the administration of the New Jersey Environmental Infrastructure Financing Program, referred to as "H2Loans," and specifically the

- DEP will provide staffing assistance in computer programming; and
- The Trust will procure information technology equipment, software and licenses (hereafter "IT equipment") in an amount not to exceed \$760,260; and

WHEREAS, in Resolution No. 13-72, the Board authorized the Executive Director to solicit pricing for such IT equipment pursuant to New Jersey Environmental Infrastructure Trust Polcy No. 4.00, "Purchase of Goods and Services;" and

WHEREAS, Trust staff solicitated quotations from firms under contract with the State of New Jersey and recommends procuring IT equipment from the following firms at the following amounts as more fully set forth in Appendix A:
